You are hereby notified that a referendum election will be held at the Clifton Town Office, 135 Airline Road in the Town of Clifton at 8:00 A.M. on November 3, 2026 for the purpose of determining the following question:

Question 1: Do you favor authorizing the School Board of Regional School Unit No. 63 to close Eddington Elementary School?

The additional cost of keeping the school open has been estimated by the School Board of Regional School Unit No. 63 to be \$669,950.02.

The voting on Question 1 shall be by secret ballot referendum. The polls will be opened at 8:00 A.M. and closed at 8:00 P.M.

The Registrar of Voters will hold office hours while the polls are open to correct any error in or change a name or address on the voting list; to accept the registration of any person eligible to vote and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.
